The Annual General Meeting and conference Saturday 12 May 2007

Election of Officers.

Due for re-election in May 2007 for two years, are the posts of Hon. Secretary and Membership Secretary (now held by now held by Karen Watts and Carol Chattaway respectively), as well as the posts of two non-executive committee members (held by Sem Longhurst & Hilary Davidson). The present incumbents are standing for re-election, but other nominations are welcome and brief indications of the duties involved for the executive posts are attached.

There are five non-executive posts on the committee, two and three posts being elected alternately every two years. Non-executive officers attend the usual four half-day committee meetings held each year, like all committee members. Their chief contribution is to offer ideas and suggestions and to help with practicalities at conferences. Enthusiasm and ideas are important requirements.

The executive posts of *Newsletter Editor*, *Publicity Secretary*, and *Sponsorship Secretary* are currently vacant. Anyone interested in standing for these offices should contact the Hon. Sec. Karen Watts, or the Chairman John Cherry for further information. Their details are on page 3.

The post of Hon. Treasurer is not due for re-election in 2007, however, the present holder (Linda Woolley) would like to step down soon, and if a replacement were to be found, is willing to work in tandem with her successor so as to ensure a smooth transition. The duties of Treasurer were outlined in the minutes of the 2006 AGM and can be sent to anyone interested.
